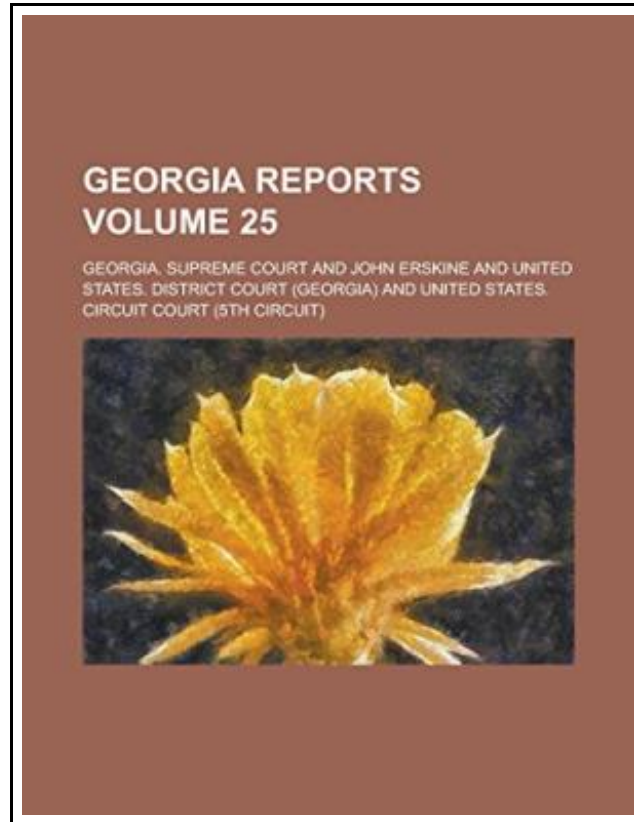

Excerpt: . . . a short time after, he called on Linton and Co. , tendered to them twen ty seven dollars and a halfin gold, and in the name of the plaintiff, demanded five barrels of flour, in pursuance of said contract, which were refused; that the grade or class of flour specified in said agreement, advanced steadily, and was worth during the next succeeding winter, from seven and a halfto eight dollars per barrel. Martin Bridwell sworn, desposed that superfine flour, in the winter of l853--54, was worth from seven and a half to eight dollars per barrel. fldrian V.
